Mitchell Township 2021 -2022 General Appropriations Act Resolution 2021-04

The Mitchell Township Board resolves:

SECTION 1: Title--This resolution shall be known as the Mitchell Township 2021 General Appropriations Act.

SECTION 2: Public Hearing on the Budget --Pursuant to MCLA 141.412 and .413, notice of a public hearing on the proposed budget was published in a newspaper of general circulation on Wednesday, March 17, 2021, and a public hearing on the budget was held on March 24, 2021

SECTION 3: Millage Levy --The Mitchell Township Board shall cause to be levied and collected the general property tax on all real and personal property within the Township upon the current tax roll an allocated millage of 0.5237 mills for township operations, voter authorized millage of 0.8000 mills for the fire department operating and voter authorized .5 mills for road maintenance and improvement. The millage levied represents the maximum amounts the township may levy by law.

SECTION 4: Adoption of budget by Activity/Department--Mitchell Township adopts the 2021-2021 fiscal year budgets for the various funds by Activity/Department. Township officials responsible for the expenditures authorized in the budget may expend township funds up to, but not to exceed, the total appropriation authorized by each Activity/Department, and may make transfers among the various line items contained in the Activity/Department accounts. However, no transfers of appropriations for line items related to personnel or capital outlays may be made without prior board approval by budget amendment.

SECTION 5: The Supervisor shall have the authority to make transfers among the various Activity/Department accounts without prior board approval, if the amount to be transferred does not exceed \$500 or 50% of the appropriation item from which the transfer is to be made, whichever is less. The Board shall be notified at its next meeting of any such transfers made, and reserves the right to modify, amend or nullify any such transfers made. Under no circumstances may the total general fund budget be changed without prior board approval.

SECTION 6: Payment of Bills--Pursuant to MCLA 41.75, all claims (bills) against the Township shall be approved by the Mitchell Township Board prior to being paid. The Township Clerk and Treasurer may pay certain bills prior to approval by the Township Board to avoid late penalties, service charges, and interest, primary utilities, and payroll in accordance with the approved salaries and hourly rates adopted in this appropriations act. The Township Board shall receive a list of claims (bills) paid prior to approval, for approval, at the next Board meeting.

SECTION 7: Authorized salary, hour, and per diem rates--Included in the various Activities/Departments are amounts of the salary, hourly, and per diem rates for the officials and employees of the Township as follows:

SECTION 10: Budget Monitoring--Whenever it appears to the Township Supervisor or the Township Board that the actual and probable revenues in any fund will be less than the estimated revenues upon which the appropriations from such fund were based, and when it appears that expenditures will exceed an appropriation, the Township Supervisor shall present to the Township Board recommendations to prevent expenditures from exceeding available revenues or appropriations for the fiscal year. Such recommendations shall include proposals for reducing appropriations, increasing revenues, or both.
